Shirley Oaks introduced herself. She lives in Victor Heights; will be retiring in a month and so will have time to volunteer

Miho Murai— made a motion to appoint Shirley as the Victor Heights representative vacancy; seconded by Bill Chin.

Wing Ho – Asked for clarification on the process for filling vacancy.

Phyllis Ling – announced vacancy at last meeting and posted notice; term of this seat is until 2025.

Bill Chin – he thinks Shirley should be in the position, she has been in the neighborhood; he has been active in the community looking for someone to apply; she has been very involved in the community

Patrick Chen – he has not met Shirley before

Miho Murai – illegal dumping on Bunker Hill Avenue; no bathroom at Alpine Recreation Center; lights

Daniel Reza- created a hot spot and have their representative come by once a week
