Retired from a career in municipal economic development planning, he has been an advocate for recognizing and preserving Chinese American history and Chinatown values. He has been a long time board member of several community organizations, including the Chinese Historical Society of Southern California and Friends of the Chinese American Museum, to promote this history.  
**Valerie Garcia Hanley** grew up in Los Angeles. She is a founding family on Olvera Street and she is a third generation merchant. She is a member of the Olvera Street Merchants Association. She is also on the board for the Olvera Street Merchants Association Foundation (501(c)3) which maintains the traditional Mexican cultural events on Olvera Street. She has worked at El Sereno Middle School for over 13 years and she continues to volunteer with Civil Air Patrol for over 30 years.
